CHANGE DETAIL:

IMPORTANT: Due to the removal of **OEP-New in the SEP drop down list for MA/MAPD plans** those utilizing **MAPA** will need to use SEP OTH and indicate in the notes “OEP” when enrolling members for OEP or OEP-New elections until the new version of MAPA is available for download.

Changes made to MAPA in this version:

1. Formatting changes to “Determine Eligibility” page.

- a. Users will now see Part A/B Date, Date of Birth and Plan Year selection is required prior to SEP selection.

3. Updated SEP options:

a. PDP SEPs

- i. SEP OEP remains for PDP selected plans
- ii. SEP S65 must be changed to now display as SEP 12J
- iii. SEP MES must be changed to now display as SEP 12G

12G	For individuals who dropped Medicare Supplement plan after enrolling in MA/MAPD for the FIRST time, can disenroll from MA/MAPD by enrolling in PDP to return to Original Medicare within 12 months of MA/MAPD effective.	<input type="checkbox"/>
12J	For individuals who elected an MA/MAPD by enrolling in PDP to return to Original Medicare within 12 months of MA/MAPD effective date.	<input type="checkbox"/>

b. All Plans SEPs

- i. SEP SPA must be changed to now display as SEP PAP
- ii. SEP LOC must be changed to now display as SEP LCC

LCC	For individual who involuntarily lose creditable prescription drug coverage as good as Medicare's.	<input type="checkbox"/>
PAP	For individuals who belong to a State Pharmaceutical Assistance Plan (SPAP) or lost SPAP eligibility.	<input type="checkbox"/>

4. 5ST SEP plan selection:

- a. Users will be presented with ONLY 5-Star plans on the “Demographics” page if 5ST SEP was previously selected on “Determine Eligibility” page.
